It was agreed to park the truck in front of the city office and put a for sale sign on it.

Budget Adjustment 2009/2010:

Gene Kelly and Brad Foster presented a report of projected June 30, 2010 Income and Expenses as well as a summary report showing budget adjustments for the year 2009/2010. They included moving the city's part of sidewalk expense from the sidewalk budget to the general budget, setting a budget for the general and the fairground – general in the amount of \$2,335.00, reducing the income budget for water income by \$17,000.00 and reducing both the income and expense for the park by the amount of the grant that was not received this year.

Alderman Dean Connolly made the motion to cut a check from the Treasure account to Fairboard general fund for \$2,335.00 seconded by Alderman Kevin Abrahamson with all in favor.

Budget Work Session:

Alderman Dean Connolly made the motion to accept the 2010/2011 budget, seconded by Alderman Andy Perkins, with all in favor.

Alderman Kevin Abrahamson made the motion to adjourn the open meeting seconded by Alderman Shawn Arends with all in favor.
